



Corrected Resolution For Approval of the Mesa Valley Community School Charter Application

Board of Education Resolution: 13/14: 89 Adopted: April 29, 2014

WHEREAS, on January 7, 2014, the District's Board of Education (Board) received a charter school application ("Application") in accordance with Board Policy LBD, Regulation LBD*-R, and the Charter School Act ("Act") from the Mesa Valley Community School ("Applicant") to establish and operate the Mesa Valley Community School as a District charter school commencing in the fall of the 2014-2015 school year; and

WHEREAS, in Resolution 13/14:33 dated November 12, 2013, the Board resolved to waive and suspend the timelines for submittal of the Application set forth in Board Policy LBD, Regulation LBD-R, and the Charter School Act ("Act") because the Application is an initiative to continue, with some modification, an existing District alternative school program (the Mesa Valley Vision Home and Community Program) that the District can no longer offer; and

WHEREAS, the District's Advisory Accountability Committee (DAAC) reviewed the Application prior to consideration by the Board in accordance with the requirements of section 22-30.5-107(1) and (1.5), C.R.S., and submitted a Memorandum to the Board dated February 18, 2014, setting forth the Committee's comments and recommendations concerning it; and

WHEREAS, the District's administrative staff worked with the Applicants to address the Application, and Applicants provided a written response to the DAAC's concerns; and

WHEREAS, after giving reasonable public notice and pursuant to section 22-30.5-107(2), C.R.S., the Board of Education held a community meeting to obtain information and comments from the public regarding the Application, which meeting took place at the Basil T. Knight Staff Development Center on February 18, 2014; and

WHEREAS, the Board reviewed the Application at an additional public meeting on March 18, 2014, at which meeting the Board met with Applicant's board of directors and received additional input and recommendations from the community, District staff and from the Applicant; and

WHEREAS, the Act requires the Board to rule by resolution on the Application within ninety (90) days after its receipt; and

WHEREAS, the Board has carefully considered the Charter School application; the statutory guidelines and requirements as set forth in C.R.S., Title 22, Article 30.5; the DAAC report, staff and community input, and the best interests of the pupils, school district, and the community; and

WHEREAS, the Board finds that the Mesa Valley Community School is in concept consistent with the purposes of the Act as set forth in section 22-30.5-102(2) and (3), C.R.S.; and

WHEREAS, the Board voted to approve the Application at its March 18, 2014, meeting, but due to a clerical error the resolution the Board adopted (Board Resolution 13/14:69) contained only recitals and did not state the action the Board took regarding the Application;

Corrected Resolution For Approval of the Mesa Valley Community School Charter Application

NOW, THEREFORE, BE IT RESOLVED that the Application is approved, effective as of March 18, 2014, for Mesa Valley Community School to begin operations as a District charter school in the fall of 2014, for the 2014-2015 school year for an initial term of four (4) years, subject to and pending satisfaction of the following condition, as well as all other terms and conditions as may be required by law.

On or before May 30, 2014, at 4:30 p.m., Applicant shall execute on behalf of the Mesa Valley Community School a charter school contract with the District acceptable to the Board both as to form and substance, and which meets the requirements of the Act.

FURTHER RESOLVED, that in the event the Board of Education determines that the Applicant has failed to substantially comply with the foregoing condition, the Application shall be deemed to be denied as of the date of such determination; provided, however, that the Superintendent is authorized to grant a reasonable extension not exceeding thirty (30) days of the deadline set forth above upon request from Applicants and their demonstration that they are unable to meet the deadline despite exercising due diligence to meet such deadline; and provided further that the deadline set forth above may be extended upon mutual agreement of the Applicant and the Board.

FURTHER RESOLVED, that this Resolution shall replace and supersede Board of Education Resolution 13/14:69, which shall have no further force or effect.
