

Grand Junction High School Construction Update Ms. Colleen Kaneda and Mr. Micah Adams with Dynamic Program Management. and Pete Icenogle with Blyth Group+ and Mr. Eddie Mort, Maintenance, Operations and Ground Director, presented updated information on the Grand Junction High School construction project. Information was shared on the project's timeline and budget, the recently completed work, work in progress and future work. Construction site photos were shared along with a drone video of the construction site. 5. Appleton Area Boundary Change Update. Mr. Shannon Bingham, Western Demographics, Inc. Demographer joined the meeting remotely to share information regarding stakeholder feedback and his recommendation regarding boundary changes for middle school students living in the Appleton Elementary School attendance area. The boundary changes would shift students from the Fruita Middle School, West Middle School and Fruita 8/9 School to Redlands Middle School. The proposed boundary changes would help in reconfiguring secondary grades in the Fruita area. He reviewed the three alternative changes from his initial proposal, requested by parents, and he shared his reasoning for recommending the alternative changes. He noted most parents surveyed, were in favor of the proposed alternative changes. 6. Elementary Declining Enrollment Committee Update Elementary Declining Enrollment Committee facilitators, Dr. Brian Hill, Superintendent, Dr. Danny Medved, Professional Learning Director, Mr. Paul Jebe, Site Director, and Mrs. Callie Berkson, Public Information Officer, were present to share updated information on the Elementary Declining Enrollment Committee. Dr. Hill reviewed the charges of the committee, shared information regarding the roles of the facilitators, the make-up of the committee, the projected enrollment numbers for District 51, and agenda items for future committee meetings. He shared graphics showing data showing student enrollment numbers, the number of schools and budgetary information, for school districts of similar size. Dr. Medved explained how the committee meetings are structured to create ongoing learning, have space for reflection, determine what information is needed to move forward and to create space where conversations and conflicts are comfortable. The structuring of the meeting enables committee members to work to define the problem and explore solutions through honest conversation. Mr. Jebe reported on helping the committee members understand what items need to be considered to support schools, such as specials (art/music), special education, and interventions, so all students can be successful. He shared graphics and information on District's elementary schools and the level of resources needed to have an ideal resourcing model and on staffing reductions needed to match staffing with declining enrollment. Mrs. Berkson reported on a timeline for the committee meetings and the projected work the committee is hoping to complete, noting the meetings are recorded, with the recordings being made available to committee members.

Strategic Plan Focus Group 2# Ms. Nikki Jost, Human Resource Executive Director, and Mr. Carter Ness, Licensed Recruiting Specialist, shared information on the work being done under the priority area of Diverse and Growing Pipelines, under the Strategic Plan Focus Group #2 of Prepared and Supported Staff. Ms. Jost thanked the committee participants for their time and input over this past year. The committee consisted of thirty-three participants, comprised of staff and community members. Updated information was displayed showing the number of positions posted for licensed staff, noting positions are now being offered to both internal and external applicants. Updated information was shared on the grant funded Pathway to Principalship Program, a program designed to advance District staff who show good leadership skills. The program will assist sixselected District licensed employees with scholarships to assist in helping them earn Principal Licensure. Dr. Danny Medved, Professional Learning Director, Ms. Heather Flick and Ms. Jamie Burnham, Instructional Coaches Coordinators, Ms. Britny Walker, Curriculum and Learning Design Specialist, Ms. Linnea Hulshof, Cultural, Linguistically and Diverse Education Coordinator, and Ms. Audrey Moralez, Redlands Middle School Instructional Coach, reported on the work being done under the priority area of Professional Learning. Dr. Medved shared information and data on the goals and the means used to measure the goals and on Data-Informed Learning Communities. Data-Informed Learning Communities will move the focus from teaching to learning, working in isolation to working collaboratively and taking collective responsibility. Ms. Burnham reported on the cultural shift of using Data-Informed Learning Communities and how implementation at the elementary level. She reported on tools and benchmarks teachers are using to make instructional decisions, and how the process of Plan-Do-Study-Act (PDSA) is implemented. Ms. Walker reviewed the work at the middle school level to build a capacity of instructional leadership teams to lead learning communities to have structured collaboration within and across buildings. She shared data showing improvement in identifying and reducing learning gaps and staff finding value in learning communities. Information was shared on steps moving forward. Ms. Hulshof shared information on the progression of work completed to meet the needs of diverse learners. She shared the goals for this next year of the work being done by elementary and secondary advisory teams transitioning to the site and learning community levels. Ms. Baskin reported on school level strategies to improve a student's sense of belonging and social emotional needs. Data was shared showing growth at the elementary level, but not as much growth at the secondary level. She shared information on next year's goals with school at the



Resolution To Shift The Boundaries For Middle School Students Living in the Appleton Elementary School Attendance Area

Board of Education Resolution: 22/23: 105 Tabled: May 2, 2023

WHEREAS, the Board of Education's vision is to engage, equip, and empower each and every student every day; and

WHEREAS, the District has been experiencing declining enrollment since 2019; and

WHEREAS, the District's demographer, presented stakeholder information, to the Board of Education, showing the majority of stakeholders, in the Fruita area, prefer the secondary schools in the Fruita area return to a traditional grade configuration of grades sixth through eighth and ninth though twelfth; and

WHEREAS, families, of middle school students living in the Appleton Elementary School attendance area, and the general public were invited to attend a community meeting to discuss proposed boundary changes; and

WHEREAS, information from the community meeting, along with the demographer recommendations were shared with the Board of Education; and

WHEREAS, shifting middle school students, living in the Appleton Elementary School attendance from Fruita Middle School, Fruita 8/9 School and West Middle School to Redlands Middle School, would be beneficial in helping the District address staffing and programming issues currently being experienced at the middle school levels and beneficial in transitioning the Fruita area secondary schools back to traditional grade configuration; and


WHEREAS, the area for the boundary shift is described as: Beginning at the intersection of 26 Road and G Road in Mesa County, Colorado; thence westerly along the centerline of G Road to the Colorado River; thence westerly along the Colorado River to the centerline as extended southerly of 22 Road in Mesa County; thence northerly along the centerline of 22 Road to the centerline of L Road; thence easterly along the centerline of L Road and the alignment of L Road as extended easterly across unoccupied BLM land to the alignment of 26 Road as extended northerly; thence southerly along said alignment and southerly along the centerline of 26 Road to the point of beginning; and

WHEREAS, boundary changes would go into effect for the 2023-2024 school year for incoming middle school sixth graders living in the Appleton Elementary School boundary as described above; and

WHEREAS, busing will be provided, at no cost, for middle school students currently residing in the Appleton Elementary School as described above to Redlands Middle School starting the 2023-2024 school year; and

WHEREAS, affected students who would be in sixth grade in the 2023-24 school year, and would have siblings in the seventh or eighth grade who will be attending school at Fruita Middle School, Fruita 8/9 School or West Middle School during the 2023-2024 school year, will be grandfathered into Fruita or West Middle School, if they choose to remain in order to allow all family members to attend the same school; and

WHEREAS, busing will be proved, at no cost, for sixth grade siblings who would be grandfathered according to the stipulations described above and for seventh and eighth grade students who live in the shift area to continue at their current school for the 2023-2024 school year as they are phased out of their current assignment; now

THEREFORE, BE IT RESOLVED, the Board of Education hereby wishes to address programming and staffing issues caused by declining enrollment and transition the Fruita area secondary schools to a traditional configuration of sixth through eighth and ninth through twelfth; now

THEREFORE, BE IT FURTHER RESOLVED, the Board of Education hereby directs the Superintendent to work with the District's demographer to make the necessary boundary adjustments to shift middle school students residing in the Appleton Elementary School shift area to Redlands Middle School.
