

The gatekeeper or administration could review context of the complaint, then decided if the book should be pulled. She reported Jeffco School District has a committee that includes librarians and teachers who make book decisions together, rather than one single gatekeeper, which she feels is the more appropriate way for such decisions to be made. Tom Sheeran, Grand Junction 81507 Mr. Sheeran thanked Mr. Will Jones for continuing to support the Dads on Duty Program and stated Dr. Hill has provided tremendous leadership to the District. Mr. Sheeran spoke about policies, standards, and CORA requests he previously submitted regarding library books. He noted not finding much in District policies regarding standards for book selection. He stated legal obligation for book selection is vested with the Board, although they may delegate to others. He feels a district this large should have policies which clearly define criteria for book selection and books should be appropriate for elementary, middle and high school levels. He stated the book <i>Jack of Hearts</i> is in Palisade High School's library and is inappropriate. Jason Marsh, Fruita 81521 Mr. Marsh spoke about teacher boundaries, specifically about decorations in his eleventh grader's classroom and a survey sent out regarding which pronoun a student would like to use. He believes teachers should have influence but shouldn't sway sexual ideologies and he wanted to know if this was against policy. He requested the Board put a policy in place for teachers to use stating parents should make decisions, not the teachers. He stated he wants boundaries put in place for teachers going forward. At the end of June, nearly 12,000 students, educators, and volunteers headed to Atlanta, Georgia for the Future Business Leaders of America (FBLA) National Leadership Conference. The annual event brought together middle and high school students for competitive events with cash prizes, learning workshops, and career development opportunities.

FBLA is an organization that inspires and prepares students to become community-minded business leaders in a global society through relevant career preparation and leadership experiences.

This year, the Board is excited to recognize the remarkable achievement of two District 51 Palisade High School seniors who placed in the top 10 at the National Competition. Bailey Edwards, placed ninth in Accounting 1 and Trevor Rund, placed tenth in Help Desk Role Play.

Their dedication, hard work, and commitment have paid off, showcasing their exceptional skills and talents on a national platform. Not only have they represented District 51 incredibly well, but they have also raised the bar for excellence within our District's FBLA program.

The Board of Education and Superintendent Hill are proud to recognize these students for their hard work and accomplishments at the Future Business Leaders of America competition and wish them the best of luck in future endeavors.

Fruita Reconfiguration Update

- Board Resolution
 - The Board of Education hereby wishes to address programming and staffing issues caused by declining enrollment at Fruita Middle School and to transition the secondary schools to a traditional grade configuration.
 - The Board of Education hereby directs the Superintendent to begin working with District staff to make the recommended and necessary changes needed to transition the secondary schools in the Fruita area to a traditional grade configuration of grades sixth through eighth and ninth through twelfth.
- Change Fall 2023
 - Initial boundary changes have taken effect for 6th grade in the Wingate and Appleton attendance areas.
- Change Fall of 2024
 - Initiate boundary change for 9th grade students from Wingate and Appleton attendance areas.
- Completion of reconfiguration Fall of 2025
 - Transition of Fruita students to GJHS is complete

Fruita Reconfiguration Planning

- The initial proposal was to phase out transition students identified for boundary changes one grade per year, consolidate a school and reconfigure three schools into a single middle school (6th-8th) & a single high school (9th-12th) for the 2025/26 school year.
 - The original 2025/26 final implementation schedule requires the district to continue to operate/fund 2 small middle schools at lower enrollment for two years.
- If all shifts/adjustments are made in the 2024-25 School year
 - The district would create a Fruita Middle School (6-8) and a Fruita Monument High School (9-12) by moving from 3 secondary schools in Fruita to 2. This would increase student enrollment at both schools while minimizing any staff reductions. Small school operation would only last for one school year.
- Further data gathering will be needed to to be conducted to determine which year is most feasible for the final change.

Fruita Grade Reconfiguration Initiative – Status

- The District staff is working to update forecasting of FMHS, GJHS, Fruita 8-9 and Fruita MS as current count data becomes available
- The results of this revised forecast will be used to determine the timing of the eventual ninth grade transition: SY 24-25 or SY 25-26
- The administration will work with staff to address the logistics of transition of the FMHS facility to eventual grade 9-12 operation:
- Planning for a stakeholder input process is underway for phased boundary changes which are proposed to begin SY 24-25 whether the eventual 9th grade transition happens in SY 24-25 or SY 25-26
- Town hall meetings:
 - In person Oct 4th RMS and Oct 5th at Fruita 8/9
 - Virtual Oct 11th Online all meetings will be 5:00-6:30
- Communication with administration and staff will be ongoing as decisions proceed

Fruita Grade Reconfiguration Initiative – History

- During SY 22-23, the district began to explore the eventual reconfiguration of Fruita schools to a K-5, 6-8, 9-12 grade structure.
- The District began shifting school boundaries to redirect Appleton area students to RMS with the intent of reducing the size of the 9th grade class at FMHS.
- The changes were deemed feasible given declining enrollment in the area, the planned activation of the new GJHS and continuing long-term school size challenges with the Fruita middle schools
- In May of 2023, two scenarios were identified that would initiate a phased boundary change of students in the Appleton and Redlands areas from FMHS to GJHS, one grade at a time, beginning in SY 24-25
- The second step in the plan to reconfigure FMHS to full grade 9-12 operation (housing all Fruita 9th graders in the building) would follow in SY 24-25 or in SY 25-26 after the boundary change made room for the additional students
- In late summer of 23, the administration began work on a stakeholder process for the boundary changes that would occur in early fall of SY 23-24 and to collect current data necessary to determine the timing of when the 9th grade transition would occur: SY 24-25 or in SY 25-26
- Detailed analysis is underway to determine -when enough space will be available for incoming 9th grade students as the outgoing boundary change students matriculate out
